

# HORSE BOARDING AGREEMENT

Spur Stables will keep the above mentioned equine(s) in a "stall with run". It is agreed between Spur Stables and Owner(s) that hay will be fed twice per day only. All grain, vitamins, minerals and/or supplements of other nature shall be supplied solely by the Owner(s). It is also agreed that training of the equine(s) by Spur Stables is not required or requested. All annual shots must be up to date and given on an annual schedule (i.e. Tetanus, Influenza, Rhinopneumonitis and West Nile Virus). All rules posted within the barn(s) shall be adhered to with no exceptions.

In the event the equine(s) require the service of a veterinarian, Spur Stables will make every effort to contact the Owner(s) through the telephone numbers listed above. Should Spur Stables not be able to contact the Owner(s), Spur Stables is hereby authorized as "agent for owner" to contact the above listed veterinarian, horse insurance company (as applicable) and/or (other veterinarian) \_\_\_\_\_, phone number \_\_\_\_\_. All fees or services occurring due to the above mentioned equine(s) shall be the sole and exclusive responsibility of the Owner(s). Spur Stables is released from any and all liability whatsoever for such fees incurred by the above equine(s). Init \_\_\_\_\_

In the event the Owner(s) become thirty (30) day delinquent in payment of board services or other services rendered at the request of the Owner(s), Spur Stables shall be entitled to place a lien against the above mentioned equine(s) for services rendered per N.M.S.S. 1998. Before placement of the lien, a fifteen (15) days prior written notification will be sent certified mail to the Owner(s) above address. Init \_\_\_\_\_
